**Declaración conjunta de 127 organizaciones de derechos humanos
Sobre la Conferencia de la Unión Interparlamentaria
Pedimos a los participantes que se trabaje para detener todas las formas de
represión y persecución política en Bahreín**

La Unión Interparlamentaria (UIP) celebrará su 146ª Asamblea en el Reino de Bahrein entre el 11 y el 15 de marzo de 2023. Se espera que participe un gran número de parlamentarios y observadores internacionales de 179 países.

En esta ocasión, las organizaciones de derechos humanos abajo firmantes expresan su profunda preocupación por el continuo deterioro de la situación de los derechos humanos en Bahreín, a la luz de un entorno que restringe las libertades públicas, mientras que hay detenciones continuas, crímenes de tortura, condenas a muerte, malos tratos, juicios injustos, ausencia de libertad de prensa y malas condiciones carcelarias, además de la disolución de las sociedades políticas de oposición y la confiscación de los derechos políticos por las autoridades. De hecho, los defensores de los derechos humanos, incluido el activista de derechos humanos Abdulhadi Al-Khawaja, ex presidente del Centro de Derechos Humanos de Bahreín, y los líderes de la oposición, incluido el jeque Ali Salman, secretario general de la Sociedad Islámica Nacional Al-Wefaq, siguen encarcelados.

Las organizaciones de derechos humanos abajo firmantes piden a los participantes en esta conferencia que arrojen luz sobre las cuestiones de derechos humanos en Bahreín y trabajen para detener todas las formas de represión política y persecución, abolir la violencia política en particular, las sentencias de muerte y la ley, y detener otras violaciones graves. Además, las organizaciones piden a los participantes que exijan la liberación incondicional de todos los presos de conciencia y la reparación, el logro de la justicia transfronteriza, la detención de los juicios





injustos, el énfasis en el principio de la libertad de opinión y expresión, la restauración de las nacionalidades y la no persecución de los disidentes, incluidos los antiguos parlamentarios.
